“There are as many as 2,07,000 temples in Karnataka & the total income of these temples amounts to 72 crores. Out of this, only a sum of 6 crores are being spent by the Government for their upkeep. On the other hand, the Govt. spend a phenomenal amount of Rs 50 crores for the madrassas & Rs 10 crores for the churches (from Govt. funds) -Sri Sri Ravishankar, 2003

Temples in India are under Government control. Only 18% of revenue generated is given back to temples and 82% used at Governments discretion. Looting, massive sale of temple lands at throw away prices, demolition, illegal encroachments is occurring all over South India.

Funds are used for awareness campaigns and legal expenses. Several illegal sales of temple lands were challenged in High Court and put on hold. Kamal Kumar Swami of GHHF walked several miles in 3 series of Pada Yatras visiting hundreds of temples in several villages bringing awareness to more than a million people. GHHF supports our sister organization Devalaya Parirakshana Samithi in an effort to save temples in India.
